2.	Q&A 1: Funding: Q: How would a 3G pitch be funded? A: There are no firm plans at this stage. There are grants and donation options which will need to be explored and a strong	Info		

	preference not to incur any more debt. The rationale of voting before establishing funding is to a) avoid to expending time and effort on exploring funding options if there is no support from the members and b) the case for securing grants / funding is considerable stronger if the members are demonstrably supportive.		
3.	Q&A 2: Scrutiny / Accountability Q: What opportunities will members have to view the outcomes of the next level of analysis if the motion is carried? A: The Society Committee (who members have a chance to elect in June) are embedded in the Working Groups and are accountable to members. They support and scrutinise the Club Board on behalf of the members. Society members will have an opportunity to discuss and debate once a proposal is complete.	Info	
4.	Q&A 3: Future Votes Q: Will there be an opportunity to vote on the output of next phase? A: There are no further votes / EGM's scheduled. Its is hoped that the transparency and scrutiny currently in place, along with the excellent working relationship which exists between the Club Board and the Society Committee would negate the need. We have understandings in place which include the fact that we will not jeopardise promotion to the EFL if the current pitch rules are in place if (when?) we are a position to be promoted.
