	There is not complete agreement and some concern amongst members re. the decision to participate in the play-offs, for both financial and safety reasons. Its worth noting that having entered the league and attained 4th place, as soon as it became apparent play-offs could take place, the club was duty bound to participate. It feels like an obligation as being part of the league, but more importantly it's an obligation to the management and players who've got us to that point and deserve the chance to earn promotion, and to the fans who turned out in huge numbers supporting us to get there. It would send all the wrong signals if we hadn't participated and seemingly had no ambition. We are doing this with eyes open and believe we're approaching it with stronger foundations than the previous promotion - albeit with the new challenges (that everyone else
